1.3.3. (Added) **Housing Council.** The 81 SPTG/CC chairs the Council and appoints Housing Representatives. Tenure of duty is 24 months. Commanders should relieve Housing Representatives from other unit details. The Housing Facilities Manager will notify unit commanders when a member has been relieved of Council duties.

1.3.3.1. (Added) Duties.

1.3.3.1.1. (Added) Housing Representatives will:

1.3.3.1.1.1. (Added) Monitor the facilities and conditions within their designated housing area.

1.3.3.1.1.2. (Added) Attend the quarterly Council meeting. If unable to attend, Housing Representatives must make sure an informed alternate attends.

1.3.3.1.1.3. (Added) Greet newcomers and outline their responsibilities to the community.

1.3.3.1.1.4. (Added) Serve as liaison for their designated area.

1.3.3.1.1.5. (Added) Select area nominees for the yard of the month program.

1.3.3.1.1.6. (Added) Upon request, assist in resolving conflicts among occupants.

1.3.3.1.2. (Added) Council Chairperson will:

1.3.3.1.2.1. (Added) Chair quarterly Council meetings and approve the agenda.

1.3.3.1.2.2. (Added) Coordinate with Housing Manager, 81st Services Squadron Commander, and Security Forces on problems and projects.

1.3.3.1.3. (Added) The Manager, Housing Flight, will:

1.3.3.1.3.1. (Added) Assist the Council Chairperson in resolving problems.

1.3.3.1.3.2. (Added) Prepare a package of pertinent regulations and guidance for Housing Representatives.

1.3.3.1.3.3. (Added) Record and distribute minutes for quarterly Council meeting.

1.3.3.1.3.4. (Added) Assist in obtaining materials for self-help projects.

1.3.3.1.3.5. (Added) Nominate representatives for appointment by the Support Group Commander.

1.3.3.1.4. (Added) The Security Forces will assist the Council Chairperson in matters within their jurisdiction such as traffic, parking, and pet control.
