SUBJECT: INTERIM MESSAGE CHANGE (IMC) 94-1 TO AFR 177-101,
FEBRUARY 15, 1991

PART I

1. PAGE 60, PARAGRAPH 6-31B. DELETE REFERENCE TO "AF FORM 220, REQUEST AUTHORIZATION AND PAY ORDER BAS-SEPARATE RATIONS" IN THIRD LINE AND ADD THE FOLLOWING SENTENCES AT END OF PARAGRAPH BUT BEFORE NOTE, "THIS AUTHORITY CANNOT BE USED TO CERTIFY AF FORM 220 WHEN STARTING ENLISTED MEMBERS' ENTITLEMENT TO SEPARATE RATIONS. BASIC ALLOWANCE FOR SUBSISTENCE MAY ONLY BE CERTIFIED BY THE MEMBER'S COMMANDER."

2. PAGE 152, PARAGRAPH 17-9.

A. IN SUBPARAGRAPH 17-9A: CHANGE REFERENCE TO DOD FAR SUPPLEMENT IN THE LAST SENTENCE FROM 208.7008 TO 253.208-1 AND ADD THE FOLLOWING: "A MIPR MUST BE CERTIFIED FOR FUND AVAILABILITY BEFORE IT IS ISSUED. THE DEFENSE FEDERAL ACQUISITION REGULATION SUPPLEMENT (DFARS), SUBPART 217.5, AND AFR 800-2 REQUIRE INTERAGENCY ACQUISITIONS UNDER THE ECONOMY ACT; I.E., MIPR'S, TO BE SUPPORTED BY A DETERMINATION AND FINDING (D&F) THAT THE ORDER BEING PLACED IS IN THE BEST INTEREST OF THE DEPARTMENT OF DEFENSE. THE D&F IS PREPARED BY THE CONTRACTING OFFICER AND MUST BE INCLUDED WITH THE MIPR BEFORE FUND AVAILABILITY CAN BE CERTIFIED."

B. IN SUBPARAGRAPH 17-9B: CHANGE REFERENCE TO DOD FAR SUPPLEMENT FROM 208.7009 TO 253.208-2.

3. PAGE 288, PARAGRAPH 28-8E. CHANGE LAST SENTENCE TO READ: "NEGATIVE IBP REPORTS ARE REQUIRED FROM ALL BASES."
