PART I.

1. DELETE SECTION 29-9B AND 29-9C, CHAPTER 29 OF THE SUBJECT  
REGULATION. THE REPORTING REQUIREMENT FOR RECOVERIES OF PRIOR YEAR  
OBLIGATIONS AND THE REPORTING REQUIREMENT FOR ANNUAL SCHEDULE OF  
INDEPENDENT UNLIQUIDATED OBLIGATION REVIEW HAVE BEEN RESCINDED.

2. REVISE THE REMAINING SECTION 29-9 TO READ: "SUPPLEMENTAL STATUS  
OF FUNDS DATA: REPORT MILITARY PERSONNEL APPROPRIATION REIMBURSEMENT  
DATA IAW DFAS-DE 7077.2-M (FORMERLY AFM 177-370) SECTION 75.

3. DELETE SECTION 29-11B, 29-11D, AND 29-11E, CHAPTER 29 OF THE  
SUBJECT REGULATION.

4. REVISE THE REMAINING SECTION 29-11 TO READ AS FOLLOWS: "29-11  
DUE DATES AND DISTRIBUTION:

A. PREPARE AND SUBMIT THE END-OF-THE-MONTH REPORTS TO  
DFAS-DE/ADR BY THE DATE PRESCRIBED.

B. SEND THE REPORT FOR THE NATIONAL IMAGERY AND MAPPING AGENCY  
(NIMA) APPROPRIATIONS TO NIMA TOPOGRAPHIC CENTER, CODE 29310, 6500  
BROOKS LANE, WASHINGTON D.C. 20135. FTP ADDRESS IS NIMAHTC CODE  
LMF, RUEOPAA, CONTENT INDICATOR CODE IAZZ.

C. DUE DATES AND DISTRIBUTION. SEND SUPPLEMENTAL STATUS OF  
FUNDS DATA, PRESCRIBED IN PARAGRAPH 29-9, TO ARRIVE AT THE  
FUNDING COMMAND ACCORDING TO THE FOLLOWING SCHEDULE:

(1) MONTHLY: SUBMIT MILITARY REIMBURSEMENT DATA WITH
