1. PAGE 50, CHAPTER 6. DELETE ENTIRE CHAPTER. THIS CHAPTER WAS INCORPORATED INTO DOD FMR 7000.14-R, VOLUME 5.
2. PAGE 70, CHAPTER 7. DELETE ENTIRE CHAPTER. THIS CHAPTER WAS INCORPORATED INTO DOD FMR 7000.14-R, VOLUME 5.
3. PAGE 79, CHAPTER 10. DELETE ENTIRE CHAPTER. THIS CHAPTER IS NO LONGER APPLICABLE.

4. PAGE 210, PARAGRAPH 27-32F(1) AND (2). REPLACE THESE TWO SUB-PARAGRAPHS ENTIRELY WITH THE FOLLOWING:

" (1) INDIVIDUAL ITEMS ON DETAIL LISTS SUPPORTING VOUCHERS IN THE REGISTER OF TRANSACTIONS BY-OTHERS MAY BE RECEIVED (THROUGH DFAS-DE) FROM THE FOLLOWING DISBURSING STATION: 525700.

(2) THE ACCOUNTABLE STATION MAY REJECT INDIVIDUAL ITEMS ON DETAIL LISTING PAID BY THIS STATION FOR AMC BILLINGS. TO REJECT AN INDIVIDUAL ITEM ON AMC BILLINGS, FOLLOW THE INSTRUCTIONS IN PARAGRAPH 27-32C."

5. PAGE 334, CHAPTER 30 (AS CHANGED BY IMC 98-3, DATED 161500 MAR 98) SUBPARAGRAPH 30-1C. REPLACE THE ENTIRE SUBPARAGRAPH WITH THE FOLLOWING:

"C. OBTAIN THE ANNUAL MILITARY PERSONNEL STANDARD RATES FROM AFI 65-503, TABLE 20-2, FROM THE INTERNET SAF/FM WEB SITE, AS FOLLOWS:

(1) TYPE "HTTP://WWW.SAFFM.HQ.AF.MIL/SAFFM/", USING LOWERCASE LETTERS EXCEPT FOR THE LAST "SAFFM" WHICH IS TYPED IN CAPITAL LETTERS. THIS WILL BRING UP THE SAF/FM HOME PAGE.

(2) THEN CLICK ON "SAF/FMC" (THE DEPUTY ASSISTANT SECRETARY FOR COST AND ECONOMICS), AND SCROLL DOWN AND CLICK ON "AFI 65-503, COST AND PLANNING FACTORS".

(3) AND FINALLY CLICK ON "TABLE A20-2 -MILITARY PAY RATES PER UNIT TIME" FOR FY 1999 RATES."

5. DELETE SUBPARAGRAPH 30-1(2).
