

# KEESLER DISCIPLINE CORNER

## Two Airmen Convicted of Drug Abuse

A Senior Airman from 81 IPTS pled guilty at a Summary Court-Martial for smoking marijuana on 3 occasions (in violation of Article 112a, UCMJ). The Senior Airman was caught when he tested positive during a random urinalysis. A Summary Court-Martial Officer sentenced him to reduction to E-1, forfeiture of \$1,031.00 pay for 1 month, 45 days of hard labor without confinement, and a reprimand.

A Senior Airman from the 81 SFS pled guilty at a Summary Court-Martial for smoking marijuana on 2 occasions (in violation of Article 112a, UCMJ). The Senior Airman was caught when he tested positive during a random urinalysis. A Summary Court-Martial Officer sentenced him to Reduction to E-2 and forfeiture of \$1,156.00 pay.

### 81 TRW ARTICLE 15S

#### Insubordinate to a Noncommissioned Officer (NCO)

- An A1C from the 338 TRS was punished for insubordinate conduct towards a noncommissioned officer, in violation of Article 91, UCMJ. The Airman disobeyed an order to report to a location specified by the NCO, and later chest-bumped the NCO. The Airman received a reduction to E-2, 10 days of extra duty, and a reprimand.

#### Dereliction of Duty

- An AB from the 335th TRS was punished for violating a general order prohibiting hazing, in violation of Article 92, UCMJ. The Airman received a forfeiture of \$773.00 for two months with one month suspended, restriction to Keesler Air Force Base for 30 days, and a reprimand.
- An AB from the 335th TRS was punished for violating a general order prohibiting hazing, in violation of Article 92, UCMJ. The Airman received a forfeiture of \$773.00 for two months with one month suspended, restriction to Keesler Air Force Base for 30 days, and a reprimand.
- An A1C from the 336th TRS was punished for dereliction of duty, in violation of Article 92, UCMJ. The Airman left the local area without approval. The Airman received a suspended reduction to E-2, forfeiture of \$433.00 for 2 months, and a reprimand.
- An Amn from the 336th TRS was punished for dereliction of duty, in violation of Article 92, UCMJ. The Airman left the local area without approval. The Airman received a suspended reduction to E-1, forfeiture of \$386.00 pay for 2 months, and a reprimand.

The Airman left the local area without approval and lied about it. The Airman received a forfeiture of \$386.00 pay for 2 months and a reprimand.
- An AB from the 336th TRS was punished for dereliction of duty, in violation of Article 92, UCMJ. The Airman left the local area without approval. The Airman received a forfeiture of \$386.00 pay for 2 months and a reprimand.
- An AB from the 336th TRS was punished for signing a false official statement, in violation of Article 107, UCMJ, conspiracy, in violation of Article 81, UCMJ, and dereliction of duty, in violation of Article 92, UCMJ. The Airman conspired with another Airman to lie about providing alcohol to an underage person. The Airman received a forfeiture of \$773.00 pay for 2 months, restriction to base for 45 days, and a reprimand.
- An A1C from the 338 TRS was punished for dereliction of duty, in violation of Article 92, UCMJ. The Airman left the local area without approval. The Airman received restriction to base for 30 days and a reprimand.
- An AB from the 338 TRS was punished for dereliction of duty, in violation of Article 92, UCMJ. The Airman consumed alcohol while underage. The Airman received suspended forfeiture of \$773.00 pay, restriction to base for 45 days, and a reprimand.
- An AB from 366 TRS, Det. 6 was punished for violating a general regulation and dereliction of duty, in violation of Article 92, UCMJ. The Airman consumed alcohol while underage. The Airman received a forfeiture of \$773.00 pay for 2 months, restriction to base for 36 days, and a reprimand.
- An AB from 366 TRS, Det. 6 was punished for dereliction of duty and 2 violations of a general regulation, in violation of Article 92, UCMJ. The Airman had a member of the opposite sex in the Airman's dorm room, possessed alcohol in the dorm, and consumed alcohol while underage. The Airman received a suspended forfeiture of \$773.00 pay for 2 months, restriction to base for 30 days, 30 days of extra duty, and a reprimand.

### **False Official Statement**

- An AB from the 336th TRS was punished for making a false official statement in violation of Article 107, UCMJ; and dereliction of duty, in violation of Article 92, UCMJ. The Airman was caught consuming alcohol under age and lied about obtaining the alcohol. The Airman received a forfeiture of \$386.00 pay for 2 months and a reprimand.
- An AB from the 336th TRS was punished for dereliction of duty, in violation of Article 92, UCMJ, and making a false official statement, in violation of Article 107, UCMJ. The Airman willfully failed to be present after curfew and lied about the Airman's location. The Airman received a forfeiture of \$386.00 pay for 2 months and a reprimand.

### **Distribution of Controlled Substance**

- An Amn from the 335th TRS was punished for distributing a controlled pain medication, in violation of Article 112a, UCMJ. The Airman received a reduction to E-1, suspended forfeiture of \$867.00 pay, and a reprimand.
