81 TRW ARTICLE 15S

- A staff sergeant from 81st Medical Operations Squadron was punished for simple assault, in violation of Article 128, UCMJ. The NCO received a suspended reduction to the rank of senior airman and 14 days of extra duty.
- A staff sergeant from 81st Dental Squadron was punished for making and signing a false official statement, in violation of Article 107, UCMJ. The NCO received a reduction to the rank of Senior Airman, suspended forfeiture of \$1,241 pay, and a reprimand.
- An airman from 336th Training Squadron was punished for making an unauthorized transition card, in violation of Article 134, UCMJ. The Airman also made a false official statement, in violation of Article 107, UCMJ. The Airman received a reduction to the rank of airman basic and a reprimand.
- A senior airman from 81st MDOS was punished for making a false official statement, in violation of Article 107, UCMJ. The airman received a suspended reduction to the rank of airman first class and 10 days of extra duty.
- An airman from 336th TRS was punished for larceny, in violation of Article 121, UCMJ, and damaging or destroying property, in violation of Article 109, UCMJ. The Airman received a reduction to airman basic, suspended forfeiture of \$878 for 2 months and a reprimand.
- An airman first class from 338th TRS was punished for possessing a weapon in the dormitory, in violation of Article 92, UCMJ. The Airman received 18 days of extra duty and a reprimand.
- An airman first class from 336th TRS was punished for possessing a weapon in the dormitory, in violation of Article 92, UCMJ. The Airman received a suspended reduction to the rank of Airman, forfeiture of \$439 for 2 months and a reprimand.
- An airman from 336th TRS was punished for possessing a weapon in the dormitory, in violation of Article 92, UCMJ. The Airman received a suspended reduction to the rank of airman basic, forfeiture of \$391 for 2 months, and a reprimand.
- An airman first class from 336th TRS was punished for possessing a weapon and alcohol in the dormitory, in violation of Article 92, UCMJ. The Airman received a suspended reduction to the rank of airman, forfeiture of \$439 for 2 months, and a reprimand.
