KAFB CASE DOCKET

Courts-Martial Across 2 AF (Jan-Mar 2016)

Sheppard staff sergeant convicted of attempted larceny, AWOL, and false official statement

- A staff sergeant from the 82nd Security Forces Squadron pled guilty to one charge and specification of attempted larceny of over \$500 (in violation of Article 80, UCMJ), one charge and specification of absence without leave (in violation of Article 86, UCMJ) and one charge and specification of false official statement (in violation of Article 107, UCMJ). The approved punishment was reduction to E-1, 30 days confinement and a bad conduct discharge.

Sheppard staff sergeant convicted of violating a lawful order and adultery

- A staff sergeant from the 364th Training Squadron pled guilty to one charge and three specifications of violation of the lawful general regulation: AETCI 36-2909 for having an unprofessional relationship with a student (in violation of Article 92, UCMJ) and one charge and specification of adultery (in violation of Article 134, UCMJ). The approved punishment was reduction to E-3, four months confinement and a reprimand.

Sheppard airman convicted of fraudulent enlistment, illegal possession, use, and introduction of cocaine

- An airman first class from the 362nd TRS was convicted of one charge and one specification of fraudulent enlistment for failure to disclose pre-service drug use (in violation of Article 83, UCMJ), one charge and three specifications of possession, use and introduction of crack onto an installation (in violation of Article 112a, UCMJ), and child neglect for leaving his young child in a car while inside a home to use crack (in violation of Article 134, UCMJ). The approved punishment was reduction to E-1, confinement for 12 months and a bad conduct discharge.

Keesler AFB Court-Martial

Airman acquitted of assault, hazing, breaking & entering

- An Airman from the 335th TRS was acquitted by a special-court martial panel of officer and enlisted members for allegations he hazed a fellow Airman, (in violation of Article 92, UCMJ); assaulted another Airman (in violation of Article 128, UCMJ); and broke into an Airman's dorm room (in violation of Article 134, UCMJ).

Keesler AFB April Nonjudicial Punishment

- A staff sergeant from 2nd Air Force was punished for failing to obey a lawful order for failing to report to work, in violation of Article 92, UCMJ. The sergeant received a reduction to the grade of senior airman and a reprimand.
- An airman first class from Det. 2, 336th TRS was punished for failing to obey a lawful order by driving a government operated vehicle to the mall, in violation of Article 92, UCMJ. The Airman received a reduction to the grade of airman and a reprimand.
- An airman first class from the 334th TRS was punished for disrespecting an NCO and failure to obey a lawful order by failing to bring an NCO two 341s, in violation of Articles 91 and 92, UCMJ. The Airman received a reduction to the grade of airman and a reprimand.
