May Nonjudicial Punishment

- An airman 1st class from the 334th Training Squadron was punished for wrongfully consuming cough syrup with the intent to alter their mood or function, traveling outside the local area without prior approval, and failing to obey a lawful order by discussing an ongoing investigation with other Airmen, in violation of Article 92, UCMJ. The Airman received a reduction to the grade of airman basic, forfeiture of \$250 pay per month for two months and a reprimand.

The airman received forfeiture of \$200 pay, suspended forfeiture of \$200 pay, restriction to the limits of the Naval Construction Battalion, Gulfport, Miss. for 30 days, 15 days extra duty and a reprimand.
