July Nonjudicial Punishment

Alcohol Related Incidents

- An airman first class from the 335th Training Squadron was punished for being drunk on duty, in violation of Article 112, UCMJ. The Airman received a suspended reduction to the grade of airman and a reprimand.
- An airman first class from the 335th TRS was punished for being drunk on duty, in violation of Article 112, UCMJ. The Airman received a suspended reduction to the grade of airman, subject to the condition that the Airman refrain from consuming alcohol for 30 days; 30 days extra duty and a reprimand.
- An airman from the 335th TRS was punished for being drunk on duty, in violation of Article 112, UCMJ. The Airman received a suspended reduction to the grade of airman basic, subject to the condition that the Airman refrain from consuming alcohol for 30 days; 30 days extra duty and a reprimand.
- An airman first class from the 338th TRS was punished for driving under the influence (DUI), in violation of Article 111, UCMJ. The Airman received a reduction to the grade of airman, a suspended reduction to the grade of airman basic and a reprimand.

Miscellaneous Misconduct

- An airman basic from the 334th TRS was punished for having a member of the opposite sex in their dorm room behind closed doors, in violation of Article 92, UCMJ. The Airman received forfeiture of \$250 pay and a reprimand.
- An airman basic from the 334th TRS was punished for being behind closed doors in a dorm room belonging to the opposite sex, in violation of Article 92, UCMJ. The Airman received forfeiture of \$250 pay and a reprimand.
- An airman basic from the Det. 2, 336th TRS was punished for false official statement and stealing money from another Airman, in violation of Articles 107 and 121, UCMJ. The Airman received forfeiture of \$365 pay, restriction to the limits of Fort George G. Meade, Md. for 14 days and a reprimand.
- An airman first class from the 338th TRS was punished for having a member of the opposite sex in their dorm room behind closed doors, in violation of Article 92, UCMJ. The Airman received a reduction to the grade of airman and a reprimand.
- A staff sergeant from the 81st Medical Diagnostic and Therapeutics Squadron was punished for soliciting another Airman to commit an act of misbehavior and failing to go to the command-directed alcohol-related incident stand down briefing, in violation of Articles 82 and 86, UCMJ. The sergeant received a suspended reduction to the grade of senior airman, 15 days of extra duty and a reprimand.
