September Nonjudicial Punishment

Alcohol/Drug Related Incidents

- An airman first class from the 335th Training Squadron was punished for wrongfully using Percocet, in violation of Article 112a, UCMJ, and larceny, in violation of Article 121, UCMJ. The Airman received a reduction to the grade of airman basic, restriction to the limits of Keesler Air Force Base, Miss. for 30 days and a reprimand.
- An airman first class from the 336th TRS was punished for possessing alcohol in the dormitory, in violation of Article 92, UCMJ. The Airman received forfeiture of \$615 pay per month for two months, restriction to the limits of Keesler Air Force Base, Miss. for 30 days and a reprimand.

Miscellaneous Misconduct

- An airman first class from the 334th TRS was punished for failing to go to their appointed place of duty, in violation of Article 86, UCMJ. The Airman received a suspended reduction to the grade of airman, subject to the condition that the Airman refrain from consuming alcohol for 20 days, restriction to the limits of Keesler Air Force Base, Miss. for 60 days and a reprimand.

Miscellaneous Misconduct Cont'd

- An airman basic from the 336th TRS was punished for failing to report to special individual assistance (SIA) training, in violation of Article 92, UCMJ, and making a false official statement, in violation of Article 107, UCMJ. The Airman received forfeiture of \$391 pay per month for two months, restriction to the limits of Keesler Air Force Base, Miss. for 30 days and a reprimand.
- An airman basic from the 336th TRS was punished for entering the dormitory belonging to another squadron without prior approval, in violation of Article 92, UCMJ. The Airman received forfeiture of \$391 pay, restriction to the limits of Keesler Air Force Base, Miss. for 14 days and a reprimand.
- An airman basic from the 336th TRS was punished for assaulting and communicating a threat to another Airman, in violation of Articles 128 and 134, UCMJ. The Airman received forfeiture of \$391 pay per month for two months, restriction to the limits of Keesler Air Force Base, Miss. for 21 days and a reprimand.
- An airman basic from the Det. 2, 336th TRS was punished for leaving the local area without prior approval, in violation of Article 92, UCMJ, and making a false official statement, in violation of Article 107, UCMJ. The Airman received forfeiture of \$365 pay, restriction to the limits of Ft. George G. Meade, Md. for 14 days and a reprimand.
- A staff sergeant from the 81st Medical Diagnostic and Therapeutics Squadron was punished for failing to properly maintain the unit government purchase card (GPC) and failure to obey a lawful order, in violation of Article 92, UCMJ. The sergeant received a reduction to the grade of senior airman, suspended forfeiture of \$1,241 pay per month for two months and a reprimand.
