## **Copying Military ID Cards**

#### The General Rule:

It is against federal law to make a copy of a Military ID card. Title 18 of the United States Code, Section 701, says anyone who "photographs, prints, or in any other manner makes or executes any engraving, photograph, print, or impression in the likeness of" a Military ID "except as authorized under regulations made pursuant to law" is subject to six months in prison and/or a fine.

#### The Exception:

Air Force Instruction 36-3026\_IP, *Identification Cards for Members of the Uniformed Services, Their Eligible Family Members, and Other Eligible Personnel,* 17 June 2009, provides the sole authorized exception. Paragraph 1.8.1.1. spells out that a "cardholder may allow photocopying of their ID card **to facilitate DoD benefits**. Photocopying is prohibited in all other instances; furthermore, the photocopy shall not be used as a substitute for an ID card."

It is important to distinguish between actual DoD benefits—such as Tricare benefits— and benefits from a third party that you may receive by being associated with the DoD—such as a military discount. You should never allow anyone to copy your ID card unless it is for the purpose of facilitating DoD benefits.

#### The Alternative:

When asked to prove you are in the military, one alternative to allowing someone to copy your ID card is to print the Proof of Service Letter off of Virtual MPF. This letter can be accessed under the Self Service Actions option on the left hand side of the home page, then select Personal Data option, and then click "Proof of Service Letter," which basically provides a document to offer outside agencies to explain that the member is in fact serving in the Air Force.
