What Happens When You Get a Ticket on Base?

So you're speeding on base and you see the flashing lights of an 81st Security Forces patrol car behind you. You're pulled over and issued a citation. Now what? You have two options: Either pay the amount listed on the ticket, or schedule a court date.

It is **YOUR** responsibility to take care of your ticket! Here's how:

U.S. Federal Magistrate's Court

- The information you need to pay your ticket or to schedule your court date is found at the bottom of the Violation Notice (the ticket).
- The court will direct you to their website (<u>http://www.cvb.uscourts.gov/</u>) and you may either pay your ticket online or get your court date.
- The ticket will NOT include your court date, so make sure you call to find out when you need to appear at the U.S. Federal Court in Gulfport, MS.
- If you don't pay the ticket, or want to contest the ticket, it is your responsibility to find out your court date, and to appear in court.
- All violators are treated the same! Active duty, civilian personnel, dependents, and/or contractors are all required to either pay the ticket or to appear in court.
- If you are given a ticket and fail to pay, or do not go to the court date, the Judge will issue a federal warrant for your arrest!

Protecting Against Inappropriate Relationships During Training

As permanent party at a training base, we must all be aware of the special rules that guide our interactions with the training group Airmen. Below is a list of the activities prohibited by DoDI 1304.33.

Recruiters and trainers providing entry level training WILL NOT:

- Develop or attempt to develop any personal, intimate, or sexual relationship with a student. This includes dating, holding hands, kissing, hugging, caressing, and sexual activities. These improper relationships include card, letter, email, phone, messaging, video, photo or social networking
- Use grade or position, threats, pressure, or promise of return of favors or favorable treatment in an attempt to gain sexual favors from a student
- Allow entry of a student into their dwelling
- Share a living area
- Allow any students into your private vehicles with the very limited exceptions of official business or when their safety or welfare is at risk
- Provide alcohol to, or consume alcohol with, a student
- Attend social gatherings, clubs, bars, theaters or similar establishments with a student
- Gamble with a recruit or trainee
- Lend or borrow money or become indebted to a student
- Ask them for donations
- Hire or employ them (for example, as babysitters)

This may affect the ability of permanent party members to work as Uber drivers in their off-duty employment, as permanent party may not give students rides in their personal vehicles. Further guidance will be available for those seeking to become drivers!
